

With reference to your application for additional division for F.Y.B.M.S course from the academic year 2002-2003, I am to inform you that your college has been permitted to start one more additional division for F.Y.B.M.S. course with intake of maximum 60 students from the academic year 2002-2003 on permanently no-grant basis with the following conditions :-

- i) All admissions must be completed by the Principal by 24th August, 2002, for which merit in CET is the only criterion. Reservation policy as applicable, must be scrupulously followed.
- ii) to fulfil the conditions laid down by the University from time to time
- iii) students who have already taken admission for F.Y.B.M.S. Course are not allowed for transfer to any other college for the same course.
- iv) the attendance of a student must not be less than 75% during the academic year and the college will have to complete syllabus for all the subjects during the academic year by taking extra lectures on Sundays, holidays and during vacation period. Please inform the details of arrangements of the lectures to the University on or before 31st August, 2002.

(However, the suggestions in this regard by the University is indicated in the scheme of syllabus)
4. The college must provide additional sufficient infrastructural facilities for starting the said courses.

The local inquiry committee appointed by the University will visit the college shortly to verify the infrastructural and other facilities provided by the college for starting the said courses.
